- * **HOURS:** All booths are required to be set-up and ready by 11:00 a.m. on Friday and Saturday. Please be advised, you are contracted to stay the entire time as stated.
- * **KIOSKS:** No nails or screws can be used inside or outside of kiosks.
- * **HEATING:** Only electric heaters will be allowed in kiosks. Propane heaters are prohibited.
- * **ELECTRICAL:** One standard 110 watt electrical outlet will be provided. Vendor agree to hold the Redmond Chamber of Commerce & CVB harmless for loss of revenue or damages caused by and loss of power due to technical malfunctions, human error, weather or for any other reasons. The Fire Marshall requires that you duct tape all extension cords.
- * **CLEAN UP AND GARBAGE:** Vendors must provide one garbage can in front of their booth for public use. You are responsible for taking your garbage to the dumpster. We ask that you please make sure that your booth space is cleaned after each event.
- * **THIS IS A RAIN, SHINE, OR SNOW EVENT. NO REFUNDS.**

Disclaimer: The undersigned hereby waives and releases the Redmond Chamber of Commerce & CVB and all event volunteers, sponsors, and agents including the City of Redmond (released parties) from any and all liability of any kind arising from the undersigned's participation in the Holiday Village Market 2017 including, but not limited to claims for personal injury, property damage, lost or stolen property whether caused by negligent or reckless conduct of said released parties.
