Contractual Information

As a food establishment participating in the Music on the Green series, I agree to the following set of conditions outlined in this contract. Non-compliance with any items below will result in non-refundable termination from participation in event. Vendor space will be approximately 10x10, (more space available if needed) on the lawn in the park. To reserve your space, full payment must be included with your completed application. Visa, MasterCard & Discover accepted.

- **Hours:** All booths are required to be set-up and ready by 5:15p.m. Break-down can begin at 7:30 p.m. Please be advised, you are contracted to stay the entire time as stated.

- **Liability Insurance/Health Permits:** Participation in Music on the Green requires proof of adequate liability insurance and temporary event licenses issued by the Deschutes County Health Department. Copies of both should be faxed to 541-923-6442 or mailed to The Redmond Chamber no later than 6/10/16. Failure to do so could result in denied participation.

- **Electrical:** Power is not guaranteed. When power is provided (portable generators or otherwise), Vendor agrees to hold the Redmond Chamber of Commerce harmless for loss of revenue and/or wasted food damages caused by any loss of power due to technical malfunction, human error, or for any other reason. The Fire Marshall requires that you duct tape all extension cords. You must use 10-gauge extension cords.

- **Clean Up & Garbage:** Vendors must provide one garbage can in front of their booth for public use. You are responsible for taking your garbage to the dumpster. As a city regulation, ice must be dumped in tree wells, not on the grass. We just ask that you please make sure that your booth space is cleaned after each concert.

- **Booth Designation:** Designated upon entrance to event, some flexibility changing spaces where necessary.

- **Parking/Load & Unload:** Vehicle access on Sam Johnson Park grounds is prohibited by the parks district. Please pull up and unload on the curb close to your booth area and park further down the street to allow others to unload.

- **This is a rain or shine event. No refunds.**
