PARADE RULES:

For the safety of those watching the parade and for our participants, please obey the following rules:

- All entries must be decorated to participate.
- Participants who have floats or large entries must have people walking alongside. This is to help the control of kids who may run up to the entry/float.
- Mounted entries must have walkers next to them. This is for the safety of the horse, rider and parade spectators.
- Pooper scoopers are required for all mounted/animal entries.

RULES FOR TOSSING CANDY:

- Candy can only be tossed by individuals 12 years of age and older.
- Candy must be tossed away from the vehicle.
- Candy can only be tossed from large vehicles (e.G., Semi-trucks or pickups pulling trailers) if you have walkers on each side of your vehicle.

** Not adhering to the rules may prohibit you from participating in the parade.*
